Project Update

The project aims to bring many ecological benefits to Chichester Harbour. We have been working with Natural England and the Chichester Harbour Conservancy to utilise their expertise on environmental aspects of the project area along the coastline.

We recently completed our outline business case that explains why the project is needed and how it could work. We will soon draw up detailed engineering designs and complete work needed for our planning application. Our key partners are helping us make sure the plans and design is robust to ensure we use the land to create the best possible habitat.

This business scrutinised case was by Environment Agency national teams. After feedback, the project team are planning more environmental assessments to help with the next project stage. Soon, we will sign contracts between the Environment Agency, consultants and contractors to begin this exciting design stage before submitting final business case.

Spotlight on Species

As the Thorney Island Project aims to support and benefit numerous habitats and wildlife in the area, we are highlighting a different species each month. This month's species is a **Brent Goose**.

Brent Geese visit the UK in the winter from October to March/April. The size of population that seasonally migrate is very dependent on the success rate of breeding in the Arctic, which can vary each year. This goose is rather small in comparison to other goose species. They have a dark underbelly and neck with a white collar and white undertail. The Brent Goose often feeds on vegetation found on the intertidal habitat and grasslands in Chichester Harbour. This can range from seaweed to grass. The geese can be seen all over the Harbour in large flocks (Chichester Harbour Conservancy, 2025).

Circular Path Update

Following flooding caused by heavy rainfall and spring tides in 2023, an inspection was carried out on the eastern sluice gate of the Great Deep.

The Environment Agency, worked with Southern Water Ltd and the Ministry of Defence (MOD) to undertake repairs to strengthen the structure and reduce future flood risk. During these works, the adjacent public right of way was found to be unsafe. In agreement with West Sussex County Council, public access was suspended to allow for safe restoration.

The MOD's estate specialists from the Defence Infrastructure Organisation worked with West Sussex County Council to deliver a new crossing, completed in summer 2025. This improvement has reinstated access to the 13km circular walk, ensuring it is safe and accessible for all.
